FINANCIAL SUPPORT

Travel and daily expenses are covered by EJTN through the payment of a per diem or, where applicable, the reimbursement on a real cost basis.

HOW TO APPLY

A call for applications is launched during the autumn of each year and communicated through EJTN's Member and partner institutions and on the EJTN website.

Candidates with a strong professional motivation and good knowledge of the working language of the activity location are invited to submit their interest via the application forms available on the EJTN website.

EJTN works with its Member and partner institutions to preselect and allocate applicants according to available places in the participating countries or institutions.

Selected candidates are notified by EJTN within 2 months after the closing of the application period.



The Exchange Programme's main purpose is to enhance the European judiciary's practical knowledge of other judicial systems as well as European and human rights law through direct contacts, exchange of views and experiences between judges, prosecutors and trainers from different EU Member States (EU MS).

The Exchange Programme also aims to develop a European judicial culture based on mutual trust between judicial authorities in the common European judicial area.

ACTIVITIES INCLUDE...

Short-term exchanges in EU MS

- **General exchanges:** Organised either individually or in groups of judges and prosecutors from several EU MS, general exchanges allow participants to receive an introduction to the judicial system of the host country, attend hearings and exchange with their counterparts from the visited court or prosecution office.
- **Specialised exchanges:** Judges and prosecutors can extend their expertise in a specific area of law in a court or prosecution office of another EU MS. Over 15 specialisations are offered each year in various EU MS.
- **Bilateral exchanges:** On their own initiative, groups of judges or prosecutors from the same court or prosecution office spend a week in a court or prosecution office of another EU MS and exchange experiences and best practices on a specific topic of common interest.
- **Judicial leaders' exchanges:** Designed for court presidents and chief prosecutors, these exchanges aim to shape vital skills by focusing on issues such as leadership and management for professionals, communication and relation with the media, financial and IT management and human resources.
- **Trainers' exchanges:** Judicial trainers learn more about the host country's methodologies, pedagogical tools and programmes as well as exchange best practices with their colleagues about the training of judges and prosecutors in the EU MS.

AIAKOS Programme

The programme is addressed specifically for future and early-career judges and prosecutors, giving them the opportunity to learn about other judicial systems and training curricula, strengthening their knowledge of EU law and judicial cooperation instruments and developing beneficial contacts with counterparts that will enhance their future careers.

Training activities in European and international organisations

- **Study visits:** Organised for groups of participants from different nationalities at the Court of Justice of the European Union (CJEU), the European Court of Human Rights (ECtHR), Eurojust, the EU institutions in Brussels, the European Union Agency for Fundamental Rights (FRA) and The Hague Conference on Private International Law (HCCH), these provide beneficiaries with insights into the functioning and procedures of the host institutions.
- **Long-term training periods:** Offered on an individual basis at the CJEU, the ECtHR and Eurojust, these allow for an in-depth immersion of the participants into the work of the host institution.
