8. STUDY VISIT AT MAX PLANCK INSTITUTE FOR SOCIAL ANTHROPOLOGY "Addressing Cultural and Religious Diversity in the Courtroom"

# **Presentation**

The study visit will be organised at the **Department 'Law & Anthropology' at the Max Planck Institute for Social Anthropology.** The Max Planck Institute for Social Anthropology, located in the city of Halle in Eastern Germany, is a leading centre for research in socio-cultural anthropology. The Department 'Law & Anthropology' aims to offer a stimulating interdisciplinary forum where both anthropologists and lawyers can engage constructively and conduct cutting-edge, policy-relevant research linked to intensified interactions within and between societies, communities, and cultures in contemporary Europe and beyond. These interactions call for an in-depth assessment of the ways in which different normative orders and systems of morality coexist at various levels of decision-making. The Department strives to systematically involve legal practitioners in researching and theorizing concepts of justice and the accommodation of diversity in rapidly changing contemporary pluralistic European societies. To this end, the Department organizes an annual one-week study visit for up to 15 judges, prosecutors and court staff in collaboration with the European Judicial Training Network (EJTN).

Through a mixture of presentations, collaborative team-work exercises with Department researchers, self-study and joint discussion sessions, participants are offered the opportunity to develop in-depth contextual understanding of diversity dimensions that are of direct relevance to their judicial practice. The visit is structured around a core exercise, called *Rethinking Judgments*. Each participant is required to submit a case from their home jurisdiction and relevant to discuss the study visit's theme two weeks before the start of the visit. During the week in Halle, participants will be invited to rethink – and, if they wish, to rewrite parts of – the decision of the case they submitted, in light of the exposure to Law and Anthropology they have had. On the last day of the visit, participants will be invited to present the findings of their *Rethinking Judgments* exercise to the rest of the group. This last session will be made accessible by a wider audience of colleagues as part of an EJTN-MPI advanced webinar. Academic materials in preparation for the *Rethinking Judgments* exercise will be shared with participants before the visit starts.

For the year 2024, the following study theme will be offered for participants:

# "Religious and cultural diversity in the EU: the principle of non-discrimination and its limits"

"United in diversity" is the motto of the European Union (EU), emblematic of the ways in which countries with different cultures, traditions and languages have joined together in the European Union to work for peaceful coexistence. In addition to the enrichment and opportunity that diversity brings, however, it also represents an unprecedented challenge in European history. Respect for cultural and linguistic diversity is laid down in Article 3(3) of the Treaty on European Union and in Article 22 of the EU Charter of Fundamental Rights under the Title III Equality. In order to fully grasp the substance of the motto, emphasis must be placed on the principle of non-discrimination and on the concept of equality in combination with values that are common to the Member States and on which, therefore, the EU is founded. Article 2 of the Treaty on European Union (TEU) lists seven: respect for human dignity, freedom, democracy, equality, the rule of law and respect for human rights, including the rights of persons

belonging to minorities. The TEU emphasizes that these values are common to the Member States "in a society in which pluralism, non-discrimination, tolerance, justice, solidarity and equality between women and men prevail".

How does the judiciary throughout Europe address this challenge?

The study visit will enable judges, from all over Europe, to exchange views on how they adjudicate individual cases involving questions of inclusion of religious and cultural diversity and to what extent the principle of non-discrimination and all that it entails enables them to offer adequate solutions in individual cases. Whilst much attention is paid to the jurisprudence of the international courts, much less is known about developments in the domestic legal systems of EU Member States on the implementation of the principle of non-discrimination and the judicial interpretation of the equality principle. Particularly little is known about the decisions of the lower courts, although they often contain the relevant considerations that explain why, in a specific case, the principle of non-discrimination played a decisive role. The study visit will offer an opportunity to discuss how legal solutions are found in everyday legal practice for the most diverse conflicts that are related to religious and cultural diversity and raise questions of discrimination.

The purpose of the visit week is to enable judges from all over the European Union to discuss - across language barriers - how, in the light of what is prescribed in Article 2 of the Treaty on European Union (TEU), they see themselves contributing to the shaping of the future of European societies when it comes to securing religious and cultural diversity, and the extent to which the principle of non-discrimination actually helps them to appropriately address situations of (unjustified) unequal treatment as they arise on a daily basis.

# Requirements

Judges, prosecutors and court/prosecution staff with a **keen interest in questions of sociocultural and religious diversity in judicial practice (especially in relation to the visit's theme)** as well as a strong motivation to building bridges between legal practice and academia. One of the primary aims of the Judicial Study Visit Programme is to enable judges to jointly explore some of the questions they are confronted with in their home jurisdictions. Participants are therefore expected to **actively contribute** to in-class debates, in line with an understanding of learning as a collective endeavour. Prospective applicants are asked to submit a **short letter of motivation** in which they indicate how and why the theme of the study visit is relevant to their own judicial practice and experience, including – if possible – references to cases which could be suitable for the *Rethinking Judgment* exercise. **Good working knowledge of English** is required as the selected participants will be expected to actively contribute throughout the study visit, including but not limited to, presenting case materials from their own jurisdiction, comparative background information on their home jurisdictions and the findings of their *Rethinking exercise* on the last day of the visit.
